

**Registering as a Cambridge school**
**Cambridge school: Application fee**

Before your school can offer our qualifications, you must go through our application process, which includes an approval visit where a Cambridge representative will visit your school to understand your plans and help you to register. A school application fee applies. We will refund €630.00 of the fee if a school does not meet our standards. We retain the remainder of the fee to cover the cost of your school approval visit.

31 December 2012 was the last date for entries from new candidates for the Cambridge International Diploma in Business. Any candidates who had already made module entries by this date must complete all modules within three years of the successful completion of the first module entered. We will only accept entries for those modules up to and including the October 2015 examination session.

The Business Start-up module at Standard and Advanced Levels has been withdrawn. 31 December 2012 was the last date for entries for this module.
